What's the current status of our responsibility wrt Upgrades, Permits, promoter support etc? JD: Still doing upgrades, permits, etc

What's the timeline for changes?

Some new events (i.e. Comp Edge Gravel ride) didn't go through JD, but upgrades still are. Unclear on racing permits. Recent activity seems like we might have been alleviated of this responsibility without an official announcement

Pending 2019 Income -- USAC rebate, \$X in NEBRA surcharges?

NBX surcharge is the biggest outstanding surcharge, they just closed their permit out. USAC Q4 Rebate expected shortly

**Big to do:** Review our cash accounting method to reconcile 2018 Late Payments with 2019 -- are there late 2018 Payments that got rolled into the 2019 income? We need to make sure our 2020 budget planning is not skewed by our Quickbooks / P&L which uses cash accounting.
